- The media representative/s must submit a duly accomplished media accreditation form and a signed **CONFORME** sheet (below);
- A visit Identification Card (ID) will be issued to designated media representatives to cover President Aquino's working visit. Only those with valid Visit ID's will be allowed within the perimeter of the venues where the events of the President will be held.
